#### OPEN MEETING:

The meeting was called to order at 5:04 p.m.

# 2. <u>DISCUSS/DETERMINE INTERVIEW PROCESS TO FILL DISTRICT-AT-LARGE TRUSTEE VACANCY:</u>

Matt Myers explained the reason for the mid-term vacancy was due to the death of a Board Member. This appointment will terminate in December of 2025.

Mark Anderson, the District's legal counsel, reviewed the process as outlined in State Statute. The District has 90 days after the creation of the vacancy to fill the position. If not done within that time frame the Davis County Commissioners would make the appointment. The candidates must reside within the boundaries of the District and be a registered voter within the District. Interviews must be in an open Public Meeting. Everything must be transparent. The Board cannot go into a closed meeting to discuss candidates. It is the fiduciary responsibility of the Board to act in the best interest of the District without a personal or professional agenda.

It was determined the Board would use a scoring method and vote by ballet to fill the Trustee vacancy. Each candidate would be given 2.5 minutes to introduce themselves and give a brief description of their background, after which each candidate would answer two questions asked by the Chair.

## 3. <u>CANDIDATES TO BE INTERIVEWED:</u>

Kathy Thurston withdrew her application earlier. Robert Baskin and Dixie Weeks did not attend the meeting.

After all candidates had completed their comments, the Board began the voting process. The first round of voting ended in a tie between Carl Pond and Beverly Ward. The second round of voting resulted in Carl Pond as the winner.

## 4. CONSIDER APPOINTMENT TO FILL DISTRICT-AT-LARGE TRUSTEE VACANCY:

Motion was made by Gina Hirst seconded by Ryan Westergard to appoint Carl Pond to fill the District-At-Large Trustee vacancy. Motion carried unanimously with Trustees Burningham, Harris, Hirst, Preece and Westergard voting "aye".
